





- b) The Trustees shall meet as often as possible but not less than three times in a year for efficient management of the Trust to consider the income and expenditure and for disposing of all such other matters as may arise in such meetings.
- c) At all meeting of the Trustees, three members will form quorum.
- d) At all meetings of Trustees, Managing Trustee or in his absence the Joint Managing Trustee or in their absence any other Trustee shall be the Chairman and all decisions of the Trustees shall be by majority vote, and the Chairman shall have a casting vote in case of equality of votes.
- e) All proceedings of the meeting of the Trustees shall be recorded in a Minutes Book kept for the purpose.

5. MANAGEMENT
